1 Booking

2 Terms of Payment

All prices are net prices and are exclusive of any applicable value-added tax which the recipient of the invoice shall be additionally liable to pay. The invoiced amount must be paid in full within two weeks of receipt of invoice at the latest. 10% of the amount due (75 Euros) are to be paid already in December 2021. The remainder (675 Euros) is invoiced in October after the IZB 2022.

Please check your billing address. An additional fee of 30 Euros plus applicable German VAT will be charged for subsequent amendments to invoices.

3 Withdrawal from Contract

Withdrawal from the contract is possible for free up to one week (7 days) before the publication in the Online Marketplace and IZB-MediaCenter. The full invoice amount plus German VAT will be charged for orders cancelled less than one week before the publication. The above mentioned payment terms apply.

In case an exhibitor who has booked services should cancel participation in the exhibition, its featured presence in both the IZB-MediaCenter and the Online Marketplace will be deleted. In case of cancellation of exhibition participation from one week (7 days) prior to publication in the Online Marketplace and the IZB-MediaCenter, the invoice amount, subject to statutory VAT, shall be due for payment in full. The above mentioned payment terms apply.
